SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

General advice	Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.
If inhaled	If inhaled: Call a poison center or doctor if you feel unwell. Delayed symptoms and effects: May cause respiratory irritation. Signs/symptoms may include abdominal pain, stomach upset, nausea, vomiting and diarrhea.


